SPECIAL MEETING

Following the Pledge of Allegiance and a brief invocation, Apollo Borough council meeting was called to order by Council President, Cynthia Virostek, at 7:00 PM in the Apollo Borough Municipal building council chambers.

Present: Council members Gabrielli, Bradshaw, Swank, Kautz, Greenawalt, and Virostek were present. Daryl Goldinger was absent. Mayor Held was present. Solicitor Tim Miller was present. Cindee McDermott was absent.

Public Comments: None

A motion was made by Mark Greenawalt and seconded by John Kautz to approve the 2015 budget. Motion passed unanimously.

A motion was made by Cheryl Swank, and seconded by Mark Greenawalt, to hire Sgt. Jarred Kier as a full time police officer, effective January 1, 2015. Motion passed unanimously.

A motion was made by Mark Greenawalt, and seconded by John Kautz, to accept the resignation of Darhl Goldinger. Motion passed unanimously.

A motion was made by Cheryl Swank, and seconded by Mark Greenawalt, to approve the 2015 council meeting dates as follows, and to include a Planning committee meeting at 6:30 PM before each regular meeting: January 22, February 26, March 26, April 23, May 28, June 25, July 30, August 27, September 24, October 22, November 19, December 10, and December 17, 2015. Motion passed unanimously.

An invoice from Attorney Pascal for professional services from April-May 2014 in the amount of \$1709.50. A motion was made by Cheryl Swank, and seconded by Mark Greenawalt, to pay this invoice pending the return of the borough files, as well as a final invoice for services through the end of 2014. Motion passed unanimously.

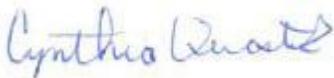

Three invoices were presented for payment for Olsen Engineering from the general fund. #13205-13207-13208 – in the total amount of \$925.56, and one invoice #13206 in the amount of \$98.00 from the sewer fund. A motion was made by John Kautz, and seconded by Mark Greenawalt to pay the invoices. Motion passed unanimously.

A motion was made by mark Greenawalt, and seconded by John Kautz, to enter into a contract with Hoffman Kennels for 2015 at a price of \$90 per month. Virostek – Y Gabrielli – Y Virostek – Y Bradshaw – Y and Cheryl Swank – Abstaining from the vote. Motion passed.
