Street Opening Ordinance

OCA did not get any responses to email sent out to utility companies last month

Need to contact regarding permits for 2017

Need to contact regarding upcoming Borough projects

N. 11th Street Culvert Replacement

Opening of connection between Scenic Drive & Pegtown Avenue

Waiting on RRWA and N. Apollo about right-of-way dedication issue

Waiting on North Apollo to perform construction work - currently no action being taken

Awaiting final design information from PADOT

Archaeological investigations will be occurring soon - equipment may be noticed on-site

PADOT will be starting ROW acquisition after environmental clearances

PADOT construction Summer of 2019 for project

Sanitary system redesign awaiting final project design from PADOT

Handicap Ramps - sent out emails regarding maximums and have not gotten responses

S.R. 0066 - N. 11th Street - Scenic Drive Intersection - OCA#201618D

PADOT has approved the traffic study

Wooster proposal has been submitted to prepare intersection design - Needs approval

Apollo Borough Sanitary Sewer Services - OCA#201718C

KVWPCA

River Offalls KVWPCA ownership transfer of diversion manholes to acknowledgement

Flow monitoring of the Apollo System to began January 1/1/17 and will continue for 6 months

The flow monitoring will be used to determine the new sewage rates for each community

Elimination of infiltration will help to reduce flow to plant and new rates for sewage

Inspection ports could be reviewed during rainfall events to verify compliance

The Rural Watershed Association could be contacted about doing inspections

A grant could be sought for getting low flow toilets installed to reduce flows

Flow data will be made available online

No data has been reported yet

Information will be reviewed when available to help target infiltration elimination

Any additional removals should be tracked

2016 PADEP required reporting data to KVWPCA by Apollo

OCA received EDU values from Kiski (250 gpd) Twp. & N. Apollo (220 gpd)

EDU calculations

Apollo Ordinance - 15,000 gpd or 167 gpd

Typical calculation - 100gpd per person - 2.36 people per household - 236 gpd

Commercial and high water users being charged more

Value to KVWPCA will most likely be under reported

May want to modify ordinance - base upon current census data

Apollo Borough Grants - OCA#201518D

Greenways - OCA#201518D.02 - approved by DCED for \$150,000 - Apollo match \$26,470.59

Multimodal - OCA#201518D.03 - approved by DCED for \$166,325 - Apollo match \$71,282.15

Funds need to be used by June of 2019

Owens Grove, N. 2nd, Hose House Alley, as one project for 2017 construction season

Railroad Street widening and trail work as other project for 2018 construction season
